

**TEACHING POSITION AVAILABLE – 22/23**  
**ECON 371 – Economics and Regulation**

The Department of Economics at Queen’s University invites applications from suitably qualified candidates interested in teaching a course in *Economics and Regulation (ECON 371)*. This is an on-campus, intermediate level lecture course with an expected enrolment of approximately 60 students. Candidates should have a Ph.D., and teaching experience at the University level in economics.

Fall term appointments will be for the period September 1, 2022 to December 31, 2022, with classes in session from September 6, 2022 to December 5, 2022, followed by an examination period.

Winter term appointments will be for the period January 1, 2023 to April 30, 2023, with classes in session from January 9, 2023 to April 10, 2023, followed by an examination period.

The University invites applications from all qualified individuals. Queen’s is strongly committed to employment equity, diversity and inclusion in the workplace and encourages applications from Black, racialized/visible minority and Indigenous/Aboriginal people, women, persons with disabilities, and 2SLGBTQ+ persons. All qualified candidates are encouraged to apply; however, in accordance with Canadian immigration requirements, Canadian citizens and permanent residents of Canada will be given priority.

The University will provide support in its recruitment processes to applicants with disabilities, including accommodation that takes into account an applicant’s accessibility needs. To comply with Federal laws, the University is obliged to gather statistical information about how many applicants for each job vacancy are Canadian citizens / permanent residents of Canada. Applicants need not identify their country of origin or citizenship, however, all applications must include one of the following statements: “I am a Canadian citizen / permanent resident of Canada”; OR, “I am not a Canadian citizen / permanent resident of Canada”. Applications that do not include this information will be deemed incomplete.
