The Department of Economics at Queen's University invites applications from suitably qualified candidates interested in teaching a course in *Topics in Environmental Economics (ECON 391)*. This is an on-campus, intermediate level lecture course with an expected enrolment of approximately 60 students. Candidates should have a Ph.D., and teaching experience at the University level in economics.

Fall term appointments will be for the period September 1, 2023 to December 31, 2023, with classes in session from September 5, 2023 to December 4, 2023, followed by an examination period.

Winter term appointments will be for the period January 1, 2024 to April 30, 2024, with classes in session from January 8, 2024 to April 9, 2024, followed by an examination period.

The University invites applications from all qualified individuals.
