TEACHING and COURSE DESIGN EXPERIENCE

Except for a sabbatical year in 2003, I have taught at Queen's continuously since September 2000. Over the last five years, I have taught over 200 students each academic year. Courses I have taught include Microeconomics, Macroeconomic Policy, Environmental Economics, Demography & Economics, and Indigenous Economics, all at the second-year level.

I have employed active learning tools such as i-clicker, TopHat, Feedback Fruits, and classrooms designed for collaboration. I have implemented many group activities to promote learning including role-playing games, poster sessions and video presentations.

The Macro Policy, Demography, and Indigenous Economics courses were designed from scratch, there being no textbook or course template. I modified the Macro course for online delivery and also put together the online 2nd year Micro Theory course using my own lecture notes. I am familiar with Moodle and D2L (onQ) e-learning platforms.

I have served the Department of Economics as its Faculty Association representative since 2013, and have been a member of the Association's Executive Committee since 2014. This year I am the Secretary of QUFA and also serve on the University Timetable Committee, the Queen's Scholars at Risk Committee, and the Indigenous Studies Curriculum Committee.
